- Stewards' inquiry and Jockey claim of foul #3 This Chick Rules (Rachael Isaacs), (finished eighth) on #4 AJ Chick In 15 (Ricardo Moreno), (finished fourth).

#3 is away slowly as the #4 comes down slightly towards the #3. The #1 Sugarmans Delight (Brian Bell), (finisihed third) and the #2 Perryfunnysteven (Cory Spataro), (finished seventh) are going out at the same time towards the #3. This puts the #3 behind the #4. The Stewards determined that the #3 This Chick Rules was compromised by the poor start. No changes required and the Jockey claim of foul was disallowed.
