## Safety First: Information and resources help prevent barn fires



According to **OMAFRA** (the Ontario Ministry of Agriculture, Food and Rural Affairs), the leading cause of barn fires (approximately 40%) are caused by faulty electrical

systems. The Ministry has recently updated its Barn Fire Prevention webpage which provides important information and education for people looking to make their farms safer.

The page contains information, checklists, videos, and a section on new technologies for preventing and containing fires. There is also an extensive list of resources to help you determine risk areas in your operation, and to provide guidance on reducing the risk of barn fires. # Changes to 2019 Thoroughbred and Quarter Horse Licensing Expiry Dates

Starting March 1, 2019, the AGCO will shift the expiry date for all individual Thoroughbred and Quarter Horse racing licences to the licensee's or applicant's birthdate.

Individual licences issued in 2019 will expire on the licensee's birthday in 2020. The licence fee will be pro-rated based on how many months a licence is extended to reach the licensee/ applicant's birthdate in 2020.

Below are two examples, followed by a chart that shows the pro-rated fee for each licence category.

**Example 1:**

*A Trainer's birthday falls in September. When they renew their Trainer's Licence in April 2019, they will be charged a pro-rated fee of \$125 – \$100 for their regular annual Trainer's Licence fee plus a one-time additional \$25 fee for the extension period, which in this case is 5 months. Their licence will then be valid until September 2020.*

**Example 2:**

*A Groom's birthday falls in October. When they renew their Groom's Licence in March 2019, they will be charged a pro-rated fee of \$30 – \$20 for their regular annual Groom's Licence fee plus a one-time additional \$10 fee for the extension period, which in this case is 7 months. Their licence will then be valid until October 2020.*

# Racing Inspectors join the AGCO's Regional Compliance Branch

On December 31, 2018, the AGCO's Racing Operations Branch (Racing Officials and Racing Investigators) was integrated into the AGCO's Regulatory Compliance Branch (RCB).

This integration helps to support the move to a new organizational structure within the RCB -- two cross-functional Regulatory Compliance teams led by RCB Directors **Rob McKinney** and **Brent Stone**.

Under this new structure, a Senior Manager will oversee the activities of the Racing Officials and coordinate racing compliance and medication control efforts. This role will also oversee provincial programs and stakeholder management, as well as play a key role on the Racing Reform project and Racing's integration into iAGCO. The Senior Manager of Racing and the Senior Manager of Veterinary Services will have a dual reporting relationship to both of the RCB Directors.

## RACING INVESTIGATORS WILL NOW BE KNOWN AS COMPLIANCE OFFICIALS

As part of this restructuring, Racing Investigators will be part of the first group of AGCO team members to move into the new role and title of Compliance Official. In order to ensure the AGCO provides a compliance function that is as effective as needed and as efficient as possible, Compliance Officials will be trained in the AGCO's other lines of business as the AGCO moves towards integrated compliance teams.



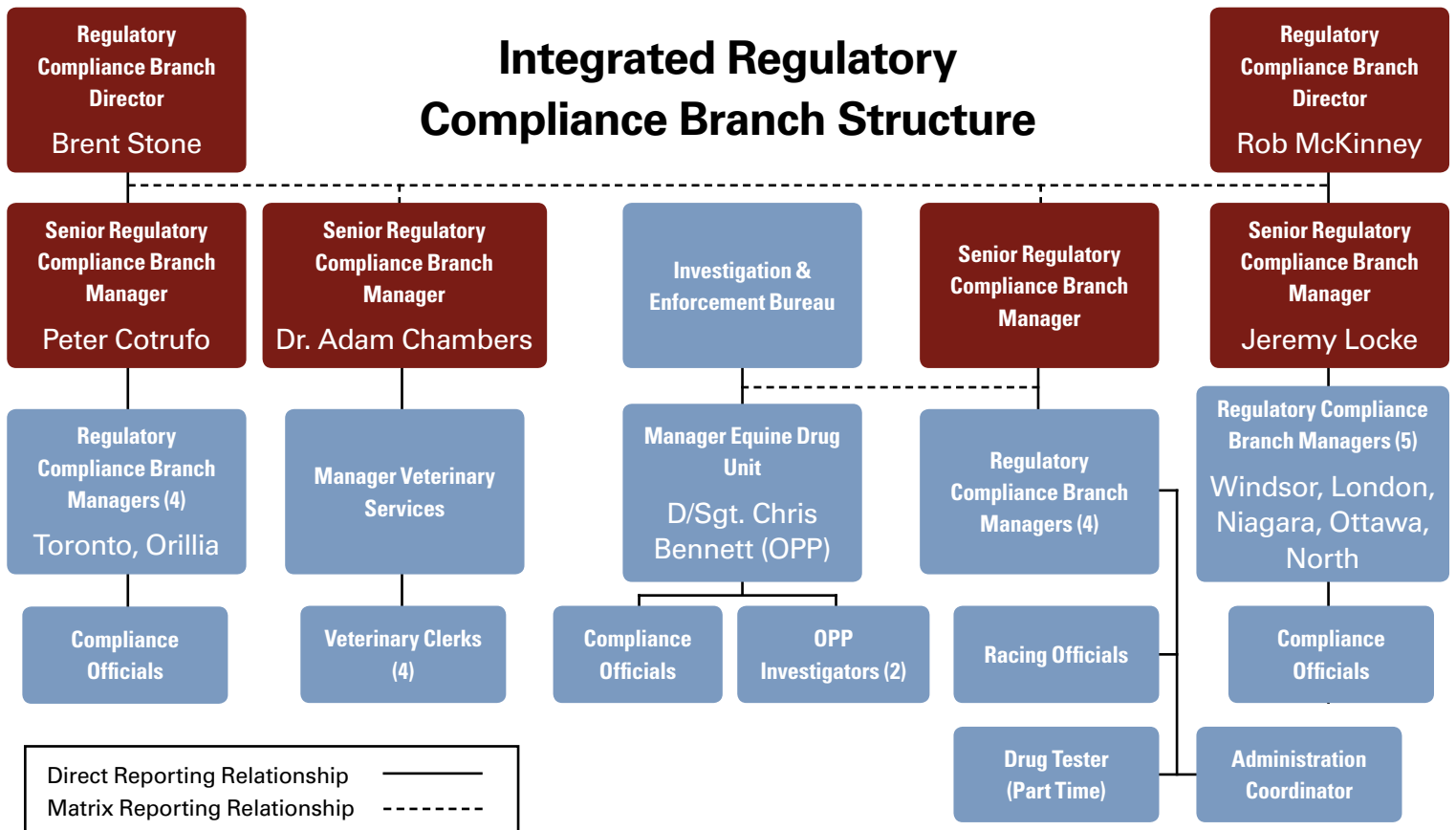

- The Compliance Officials (formerly **Racing Investigators**) will continue to serve Horse Racing primarily while reporting to their new managers in the Regional Compliance Teams, as well as supporting any compliance issues in the other AGCO business lines (e.g. alcohol service, gaming) at the racetracks.
- The Compliance Officials in the **Equine Drug unit** will continue their important work to target the abuse and misuse of equine drugs and medications and will continue to report to **D/Sgt. Chris Bennett (OPP)**.
- **Racing Officials** will continue to work in their current roles and report to the RCB Managers of Racing until the AGCO is able to complete a comprehensive review of how this role could be further incorporated into its integrated service delivery model.
- **Darla Wright** will continue to act as the AGCO Human Drug and Alcohol Testing Program Administrator (Racing) and provide administrative support for the branch.

## Information Bulletin No. 66 – Release of Standardbred Directive No. 2-2018 - Association Requirement to Provide Microchip Identifier/ Temperature Reader

December 19, 2018 – The Registrar hereby orders that all Associations conducting Standardbred racing are required to have equipment capable of scanning identifying microchips and reading temperatures in racehorses.

This Directive updates the AGCO's *Standardbred Rules of Racing*, making the updates to the following chapters, effective January 1, 2019:

- Standardbred Rules of Racing, Chapter 7: Racing Associations
- Standardbred Rules of Racing, Chapter 32: Paddock Judge and Equipment Inspector

## Information Bulletin No. 67 - Introduction of Hair Sample Testing for Quarter Horses

January 4, 2019 - With the support of the Quarter Racing Owners of Ontario Inc. (QROOI), enhanced testing for Clenbuterol will continue in the 2019 racing season, and will expand to include the collection and routine testing of horse hair samples through the Alcohol and Gaming Commission of Ontario's (AGCO)'s Out Of Competition Program. This measure aligns with the AGCO's zero-tolerance policy on Clenbuterol as outlined in [Quarter Horse Directive No. 1-2015](#).

Routine testing of hair samples will begin on July 1, 2019. Clenbuterol can be detected in hair samples several months after administration. Accordingly, the AGCO is providing the Quarter Horse industry with advance notice of the commencement of hair testing.

Any hair sample that tests positive for Clenbuterol will be considered a violation of the Rules of Racing and may result in a monetary penalty and/or a suspension.

## Ontario's horse racing industry to benefit from racing-specific online courses

Seven online courses developed by Equine Guelph will be offered at no cost to Ontario racing industry members beginning in February this year. Supported by AGCO Education, Training and Awareness (ETA) project funding, AGCO licence holders will be able to benefit from the latest learning in equine healthcare from industry experts. Three of the seven courses have been specifically designed for and will be offered exclusively to members of the Ontario racing industry.

The short courses deliver common sense, practical approaches on important topics identified by the three racing sectors – including those listed as top

priorities according to the 2016 Ontario Horse Racing Industry Survey, namely respiratory, lameness and gut health.

The courses are open to trainers, assistant trainers, grooms, jockeys, drivers and other current AGCO licence holders and will be offered on a first-come-first-served basis to the first 100 to register for each course. The next two industry-requested courses exclusive to the Ontario Racing industry will be rolled out in the winter of 2020, addressing racehorse respiratory health and injury/lameness.
