### Film Reviews:

Race 10 July 23, 2022. Justin Stein and Simon Husbands, D. Gomez as rep and G. Boulanger observed.

J. Stein horse #4 Silver Magnatized, was tipping out when Stein was trying to keep her in, Simon Husbands' mount, #9 Taquanya does take a step in as #4 goes out and #9 catches a heel and stumbles. It was determined this was a horse error incident and no penalty issued to Stein. Was informed.

### Races:

123 Entries

Race 1, Stewards' Inquiry #1 Keen Samurai, reared at the same time the starter released the horses from the gate unseating K. Nicholls. Upon review of the back tower and upper pan camera angles, there is no malfunction of the gate and no interference from the assistant starter and was deemed to have received a fair start.

Race 5, Inner turf, All clear. Notice of review issued to Jockey Sahin Civaci for failing to persevere to the finish. Notified

Race 6, Stewards' Inquiry. Stewards wished to review the stretch run as to the #7, R. Hernandez, 1<sup>st</sup>. drifting out through the stretch if the #8, J. Crawford, 2<sup>nd</sup>, impeded the progress of #8. Upon review, there is no contact, J. Crawford does not appear to stop riding. No change was made to the order.

Race 7, Queen's Plate Trial Stakes, Jockey claim of foul, #2 P. Husbands, 2<sup>nd</sup> on #9, Declan Carroll, 1<sup>st</sup> top of the stretch. P. Husbands felt it cost him and D. Carroll felt the incident was minimal and it was just race riding. Upon review of the video, both horses are running together around the turn and #9 has room to come out between horses as they go wide into the stretch. The Panel did not feel #9 caused interference to #2 that would warrant a placing.

Race 8, EPT Turf, All clear. Following the 8<sup>th</sup> race Trainer Roger Attfield submitted a Stake scratch of #4 Lady Speightspeare from the Dance Smartly Stakes.

Race 9, Woodbine Oaks, it was reported to the Stewards from the Paddock judge that #3 Moira was fractious in the paddock and tore a hind shoe from the foot, Paddock blacksmith attended but was unable to fix the issue and resolved to pull both hind shoes. The change was announced to the public. #5 Macool's Girl off a step slow. Rest ok

Race 10, Dance Smartly Stakes, Jockey claim of foul, #3 P. Husbands, 2<sup>nd,</sup> on #7, R. Hernandez, 1<sup>st</sup> inside the 1/16<sup>th</sup> pole, upon review of the upper pan and front tower camera angles, #3 is inside with #7 coming in, the Stewards felt that there is room for #3 as #7 is going by. The claim of foul was disallowed.
