#### Office:

- Two divisions of Ontario Sires Stakes Gold (second leg) three year old colt trot.
- Three divisions of Ontario Sires Stakes Grassroots (second leg) three year old colt trot.
- Early Veterinary scratch (sick) of CITY OF THE YEAR from the seventh race; this horse is entered on the short term (seven days) veterinarians list.
- Early Judges scratches (injured) of MCJAGERSONTEHMOVE from the seventh race and LARRY IS DEBS ROCK from the eleventh race.
- ONE FOR JULIUS in the first race is removed from the EIPH program, was entered off Lasix, and did not receive Lasix prior to racing today.
- Program correction in the fourteenth race for ST LADS CASH; Rodney LaFramboise should have been programmed as the driver.
- Met virtually with Benoit Lamarche and Luc Loyer regarding an outstanding invoice amount. Going forward, both parties have been informed that AGCO race officials will not mediate this dispute and any discord about this matter will need to be settled in the court system.
- Virtual review held with the driver of OUTLAWFRYREYESONLY, Normand Beaudoin, from the tenth race on 8 July regarding his urging in the stretch. Mr. Beaudoin was adjudged guilty of violating AGCO rules 22.23.01(b) (excessive) and 22.23.03(b) (more

than acceptable wrist action) and assessed a \$200 monetary penalty and three day driving suspension (15-17 July, inclusive) (SB 1252798).

- 1. FCEE N #4 (Darcy Clancy) suffered broken equipment (shoe) after the start and finished third with broken equipment. Driver of #3 ONE FOR JULIUS, Bob McClure, was cautioned regarding his urging in the stretch. Clear.
- 2. Late Judges scratch (injured) of ANGELS KID by the AGCO veterinarian; refund: \$30. Recall charged to #2 FLYING ISA N (Pascal Berube) who obstinately refused to go to the gate. Clear.
