- Robbie Robinson excused from one drive.
- Drivers excused from multiple drives: Pascal Berube (7); Samuel Fillion (2); Steeven Genois (2); Guy Gagnon (2).
- 1. Driver of #3 WHATS IN THE ESKY, Melanie Plourde, was cautioned regarding her urging in the stretch. The #4 DR JOE (Jimmy Gagnon) qualifies for breaks in two consecutive races on a fast track (trainer notified).

Discussed race pace (27² 57³ 125¹) with the driver of the race winner #1 SAULSBROOK KAISEN, Emil Toth; although his explanation was partially accepted, an official warning is entered on the licence of Mr. Toth concerning AGCO rules 22.05.01 (k) (pace not comparable to class) and he was reminded of a drivers' obligation when cutting the mile. Clear.

- 3. Reviewed the break by #5 SHADOW MARGEAUX (Clarke Steacy) after the ¼ mile pole; while off stride #5 did cause interference to #3 PRETTY BOY DUKE, #6 BET TILL DAWN, #7 STAR DOG and #8 OFFICER JONES; no placing necessary as #5 finished eighth (last). Clear.

- 4. The trainer of #6 ROLLIN WITH ROCK, Mandy Archer, was adjudged guilty of violating AGCO rule 17.19 (causing a late driver change) and assessed a monetary penalty of \$100 (Number 1869609). Clear.
- 5. Clear.
- 6. Reviewed the breaks by #7 DREYDL HANOVER (Steeven Genois) before the ¼ mile pole and before the ½ mile pole; while off stride #7 did cause interference to #5 THANKYAVERYMUCH (Jimmy Gagnon) and #8 DADDYS EYES (Drew Smyth); no placing necessary as #7 finished ninth (last). Post race #7 was examined by the AGCO veterinarian, Dr. M. Rocheleau, without remark.

- 7. A late equipment change (add blinkers) was allowed on #6 ERIKAS SHADOW (Samuel Fillion), without penalty, for safety reasons.
