Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Early Judges scratch (injured) of SOMETIMES WHEN from the seventh race by the AGCO veterinarian.
- Telephone review with driver Claude LaRose regarding his urging of TASK BAR HANOVER in the third race at Rideau on 9 July. Mr. LaRose was adjudged guilty of violating AGCO rule 22.23.03 (b) (more than acceptable wrist action) and Policy Directive 3-2019 and was assessed a monetary penalty of \$200 and a driving suspension of three days (28-30 July, inclusive) (SB 1035788).
- Telephone review with driver Ryan Guy regarding his urging of ROCKING WIZARD in the fifth race at Kawartha Downs on 11 July 2020. Mr. Guy was adjudged guilty of violating AGCO rules 22.23.01 (b) and 22.23.03 (c) and Policy Directive 3-2019 (inappropriate arm action, more than acceptable wrist action and whip outside the confines of the sulky) (second violation within a period of one year) and assessed a monetary penalty of \$300 and a five day driving suspension (17-21 July, inclusive) (SB 1035578).
