1. Reviewed the break by #6 STOLEN SECRETS (Robbie Robinson) after the ¾ mile pole; while off stride #6 did cause interference to #7 KJ ALLISON (Jacques Beaudoin), no placing necessary as #6 finished 7<sup>th</sup> (last). Clear.

  5. REYS N A ROCKET (Jonathan Lachance) #1 suffered broken equipment (hobble) before the ½ mile pole, broke (charted with an equipment break), entered the safety lane, fell and did not finish; #1 was examined by the AGCO veterinarian and found to

have minor abrasions; Mr. Lachance was examined by Rideau Carleton medical personnel and reported to be fit for racing. Clear.

6. Following the race the AGCO veterinarian placed #3 STELIOS on the vet list (injured). Clear.
7. Inquiry on #1 DIAMOND CALL (Jacques Beaudoin) concerning a break after the start; while off stride #1 did leave the course and enter the safety lane; upon re-entering the track #1 did cause interference to #3 BET TILL DAWN (Ryan Guy) who finished 4<sup>th</sup> and #6 SHRIMP AND GRITS (Pascal Berube) who finished 3<sup>rd</sup>; #1 finished 4<sup>th</sup> placed 5<sup>th</sup> (AGCO rule 22.09).
