- Equipment changes omitted from the program and announced to the public. In the first race #3 VITOR and #6 SIP OF SUNSHINE race with hopples.
- Early Judges scratches (transportation) of MARSHMALLOW FELLOW from the third race and MAJOR MOTION from the fifth race.
- Early Judges scratch (injured) by the AGCO veterinarian, Dr. Melissa Rocheleau, of MIDNIGHT SURF from the seventh race and EAU NATURELLE from the eleventh race.
- Following a complaint from a driver, track maintenance will verify that the pylons in the stretch are properly emplaced.
