

Report on day's events:

Office:

- Paddock meeting held to explain rule modifications as of 16 April.
- Early Judges scratch (ineligible; must qualify) of SAVINI from the first race.

Races:

- Samuel Fillion excused from one drive.
- 1. Start delayed due to broken equipment on #3 MONTANABLACKANGEL. Inquiry on the performance of #3 MONTANABLACKANGEL (Pascal Berube) who broke stretch and finish, #3 finished 3rd placed 5th for a double lapped-on break at the wire and failure to continuously lose ground while off stride (AGCO rule 22.27). Clear.

2. Inquiry on the performance of #1 BARRYS SHELBY (Ryan Guy) concerning possibly leaving the course before the ¼ mile pole; #1 was inside one pylon and contacted the subsequent pylon, no advantage gained and no violations.

The AGCO veterinarian examined #2 CASSIUS post-race and reported no physiological problems. Clear.

3. Clear.

4. Recall due to broken equipment (flat tire) on #3 HOLY BEING (Guy Gagnon). #4 BLOGMASTER (Stephane Brosseau) suffered broken equipment (head pole) before the ¼ mile pole and subsequently broke (charted with an equipment break) and finished with broken equipment. Clear.

- 5. Reviewed breaks by #2 THE GIRLS OF IMAGE (Robert Robinson) and #3 THINKINGOFYOUBABE (Guy Gagnon) after the start and before the ¼ mile pole; no interference and no violations of the breaking rules; #2 suffered broken equipment (stirrup) after the start and finished with broken equipment. Clear.
- 6. Clear.
- 7. Late Judges scratch (injured) of #4 WISH KEY K, refund: \$539.

Inquiry on the performance of #7 DIAMOND ROCK (Pascal Berube) who broke before the $\frac{1}{4}$ mile pole and finished 4^{th} ; no violation of the breaking rules by #7.

WATCH ME ERUPT #8 suffered broken equipment (crupper) after the start and finished with broken equipment. Clarified what is considered acceptable urging with the drivers of #2 SOUTHWIND BRONN, Clarke Steacy, and #5 AMERICAN WAY, Marie Claude Auger. Clear.

- 8. Reviewed the break by #7 APHRO STAR (Daniel Laflamme) after the ³/₄ mile pole; while off stride #7 did cause interference to #4 LEVIS DAY and #6 WHATS IN THE ESKY; no placing necessary as #7 finished posterior to the horses suffering interference. Clear.
- 9. Clear.
- 10. Reviewed the performance of #3 SIR A (Jacques Beaudoin) who broke before the ¼ mile pole and qualifies for breaks (trainer notified); while off stride #3 did cause interference to #5 GOT SEXY SCARS (Rodney Laframboise), no placing necessary as #3 finished behind #5. Clear.
