Office:

- Telephone review held with driver Richard Simard regarding his urging in the stretch while driving ARIELLE HANOVER in the eighth race on 20 August. Following a review of the video of the race Mr. Simard provided an explanation of his actions to the panel, which was partially accepted. Mr. Simard has an official warning entered on his licence regarding AGCO rule 22.23.01(a) (careless activity) and 22.23.03(b) (more than acceptable wrist action) (Number 1058430); no further action required.
- Informed the trainer of DUTCH SEELSTER, Guy Gagnon, in the second race that as this horse was declared on the EIPH (Lasix) program at time of entry, the horse was required to receive Lasix today in order to be eligible to race.
- Report received from the AGCO veterinarian concerning a post race examination of SOS JUSTIFIED on 20 August where several marks were observed. A review will be scheduled with Guy Gagnon who drove this horse in the third race on 20 August.

- 1. HLDONTGHTTOYURDRMS (Guy Gagnon) #3 suffered broken equipment (flat tire) before the ½ mile pole and pulled up, did not finish. Clear.
