Report on day's events:

Office:

 Early Judges scratch (retention) of BEAUTY IS BLIND from the eleventh race; trainer Marc-Andre Simoneau is adjudged guilty of violating AGCO rule 35.07 (failure to bring a horse on the EIPH program to the retention area by the prescribed time) and is assessed a \$100 monetary penalty (Number 2584250).

- Gordon Ley excused from one drive.
- Inquiry concerning possible interference by #2 SHADOW DAVE (Mike Healey) on #6 FRIAR VOLTAIRE (Pascal Berube) after the ³/₄ mile pole; after speaking with both drivers (Mr. Berube stated #2 did bear out and place a wheel under him forcing him wide while Mr. Healey stated that #6 had moved over to allow him out) and reviewing the race video it was determined that #2 did bear out and cause interference to #6; #2 finished second placed fourth (AGCO rule 22.09).

Driver Mike Healey will attend a review regarding AGCO rule 22.05.01 (bear out causing interference). Clear.

 Reviewed racing between #3 ILLICIT AFFAIR (Guy Gagnon), who finished second, and #6 MATTS BANK (Darcy Clancy), who finished third; #6 did contact the wheel of #3 (charted with interference) after the ³/₄ mile pole, no placing necessary and no penalty to Mr. Clancy as this was the first start for #6 and the horse was clearly on one line. Driver of #5 DA CAPTAINOBVIOUS, Claude Larose, was cautioned regarding his urging after the ³/₄ mile pole. Clear.

3. Inquiry on the race winner #5 BAYLOR BOBBY (Jimmy Gagnon) concerning the breaking rules; #5 did break before the ³/₄ mile pole but did not violate any breaking rule; no placing. Clear.

Reviewed the break by #5 THEDOGINTHEFIGHT (Ryan Guy) after the ³/₄ mile pole; while off stride #5 did cause interference to #1 REALRUBIES AT PLAY (Jason Gilchrist), #3 IMA DUDE (Stephane Pouliot), #7 WELLWORTHTHEWAIT (Brian Scott), GETYOURLICENSELIAM (Pascal Berube) & #9 PROBERTS LEGACY (Marie-Claude Auger); #5 finished eighth placed ninth for causing interference while off stride (AGCO rule 22.09).

Discussed race pace with the driver of #6 MAKE IT COME TRUE, Guy Gagnon, concerning the second quarter (28¹ 58⁴ 127 156¹); considering the explanation of the participant, track condition and weather no penalty is assessed although Mr. Gagnon was reminded of a driver's obligation when cutting the mile. Clear.

11. Reviewed the break by #2 FLASH TO THE FINISH (Guy Gagnon) after the ½ mile pole; while off stride #2 did interfere with #1 LATE NIGHT DEALER (Robert Shepherd) and #9 EL WILD SPORT (Robbie Robinson); no placing necessary as #2 finished eighth (last). Clear.
