Note: There will be a paddock meeting Sunday 4 May at 5:30 PM to discuss rules which take effect on 5 May concerning trainer stabling reporting, testing in qualifying races, new urging provisions and other issues.

- Early Veterinarian scratches (sick) of YS CHEDDAR WHEEL from the sixth race and DA TEMPTATION from the tenth race; these horses are entered on the short term (seven days) Veterinarian's list.
- Early Judges scratch (injured) of LEVIS DAY from the seventh race by the AGCO veterinarian Dr. L. Berthiaume Atack.
- Trainer Yves Tessier was adjudged guilty of violating AGCO rules 9.09(b), 26.02.01, 26.02.02 and 26.02.03(c) resulting from the Certificate of Positive Analysis (Tag # 4523120004) for the Class 3 drug arsenic (444 ng/mL) from the official sample of LITTLE MANNY (3RP53 - disqualified per AGCO rule 9.13) in the third race at Rideau Carleton on 30 April 2023. Mr. Tessier has accepted a settlement agreement constituting a fifteen (15) day full suspension (29 May to 12 June, inclusive) and a one thousand dollar (\$1000) monetary penalty, and is required to complete the AGCO Medication Use and Awareness program prior to reinstatement and has conditions entered on his licence per Policy Directive No. 3-2008 and AGCO rule 6.04 (Number 2191041). AGCO rules 18.08.01 and 26.08 apply regarding the return of purse monies and transferring horses to another trainer.

 Review with Ryan Guy of the second race on 25 May while driving SILVERADO; no further action required.

 Recall as #2 THREESIXTYFOUR (Pascal Berube) had broken equipment (overcheck) followed by another recall due to broken equipment (head pole) on #1 KEYSTONE DORAL (Jacques Beaudoin).

Reviewed racing after the start between #5 YOU GOT THIS (Emil Toth), #6 MCKEE SEELSTER (Stephane Pouliot), #7 PLACE MY BET (Philip Reid) and #10 SHAKE N BLAKE (Guy Gagnon); after reviewing the video it was determined that #5 did run in on #10 and then out on #6 (both charted with interference); no placing necessary as #5 finished posterior to the horses interfered with; no penalty to Mr. Toth. Clear.

Reviewed racing after the start between #5 CHEYENNE CREEK (Stephane Brosseau) and #6 BEDDANBURG (Robert Shepherd); after the start #5 suffered broken equipment (hopple) and subsequently broke (charted with an equipment break); while off stride #5 did cause interference to #6; no placing necessary as #5 finished ninth (last). Clear.
- 9. Clear.
- 10. Reviewed the performance of #2 SELF ISOLATION (Ryan Guy) who broke before the ¼ mile pole; while off stride #2 did cause interference to #4 LITTLE MERMAID (William Roy), #5 GRITTY (Jacques Beaudoin), #7 ROCKNROLL NATION and #10 MASTER FENCER (Guy Gagnon) causing this horse to break; while off stride #10 did suffer broken equipment (hopple) pulled up and did not finish; no placing necessary as #2 finished eighth (last). Clear.
