#### Office:

- Early Judges scratch (ineligible) of DE CHAIRMAN from the fifth race as the required documentation entering this horse on the EIPH program had not been submitted at time of entry.
- Program error correction announced for TWOMACSONEMACH in the eleventh race;
  this horse was removed from the EIPH program prior to entry and did not receive Lasix.
- Early Vet scratches (sick) of AMERICAN WAY from the sixth race and ANTOINETTE from the seventh race; both horses are entered on the short term veterinarians list (seven days).
- Early Judges scratch (injured) of STORMONT MUFFIN from the ninth race.

#### Races:

- 2. Reviewed the break by #3 LIVINGINTHEMOMENT (Phillipe Trudeau) before the ¼ mile pole; while off stride #3 did cause interference to #5 STORMONT ELIZABETH (Ryan Guy); no placing necessary as #3 finished seventh (last).
  - Inquiry on the performance of #5 STORMONT ELIZABETH (Ryan Guy), who finished second, concerning leaving the course in the last turn; #5 was inside the last pylon at the top of the stretch, did gain an unfair advantage, and was lapped by #2; #5 finished

second placed third (AGCO rules 22.05.02.2 (must have complete clearance) and 18.08.02(c) (gaining an unfair advantage)).

Mr. Guy was adjudged guilty of violating AGCO rule 18.08.02 (leaving the course) and assessed a \$100 monetary penalty (SB 1273537).

Driver of #5 BONITAS SUNSHINE, Donald Jobin, was cautioned regarding his urging in the stretch. Clear.
