- Following the races on 31 July, SPORTS JACKET was placed on the short term (seven days) veterinarians list by AGCO veterinarian Dr. Melissa Rocheleau due to lameness.
- Early Veterinary scratch (sick) of MAITRE DE LA SCENE from the fourth race; this horse is entered on the short term (seven days) veterinarians list.

- No front tower video for all races as, due to a scheduling problem, no operator was present. No back tower video for the first race as the operator was required to go to the front tower to enable the video feed. The OnPatrol manager will attend the Judges office to discuss these issues.
