R1 – Reviewed the break in the first turn by #2 Beach Fire K (Braiden Reibeling), (finished eighth). #2 interfered with #4 St. Lads Flirt (Brett Macdonald), (finished second). No placings were required.

R2 – Recall on #7 Karens Dream (wouldn't turn).

Judges' inquiry reviewed the start by #7 Karens Dream (Daryl Thiessen), (did not finish). #7 was not inside the fair start pole and was a complete parimutuel refund (\$6,935). #7 was placed on the Judges list for performance, refused and must qualify. #7 was so far back that it is not in the video.

- Reviewed pylons after the half on #6 Graceful China (Jay Harris), (finished fifth and was placed seventh). #6 was inside three consecutive pylons, finished fifth and was placed seventh for a pylon violation.

R3 – Reviewed racing at the half. There were no violations.

R4 – #4 HP Musical Alarm was entered with hopples, it was not listed in the program, the change was announced to the public.

Recall #5 HP Musical Alarm on #6 Bubble Slide.

Judges' inquiry reviewed the break before and after the start by #8 Sheriff Longmire (Jim Whelan), (finished third). There were no violations of the breaking rules. #8 was placed on the Judges list for breaks and must qualify.
