

Senior Race Official Jeff Minler has scheduled a paddock meeting for Thursday December 28, 2023 to review Standardbred rules 6.54.01 and 6.54.02 which come into effect on January 1, 2024. These rules relate to the out of competition testing of horses after a qualifier. This testing will be looking for any Analgesic, Corticosteroid, Anti-inflammatory, NSAID or local anesthetic. Also, substances that belong to the classes of drug that do not have an elimination guideline. As a reminder, horses qualifying to come off the long-term vet's list will continue to be tested, as they have been since June of 2023.
