Back Office:

- Chad Rozema is training this evening.
- Judge AI Stiff followed up with Driver Colin Kelly from Sunday April 7, 2024, at Flamboro Downs. Mr. Kelly was found to be in violation of AGCO rule 6.02 (a) (*failure to drive when programmed*) and is subject to a \$250 monetary penalty. Ruling #2609325
- The Judges held a review with Driver Bob McClure from race one on Monday April 8, 2024, decision reserved.
- Trainer Herb Holland scratched his horse Heavensdor Hanover in race one as the result of a stable error. Mr. Holland was found in violation of AGCO rule 20.03.01 (i) (*Scratching his horse as the result of a stable error*). Mr. Holland is subject to a \$100 monetary penalty, Ruling #2609249.

R2 – All clear.

R3 – Judges inquiry, reviewed racing in the stretch between #1 Settn A Precedent (James Macdonald), (finished second and was placed third) and #3 Angostura Hanover (Douglas McNair), (finished third and was placed second). #1 comes out to the #3 and puts a wheel under #3 causing the #3 to avoid the #1. #1 finished second and was placed third for causing interference to #3 in the stretch.

The Judges will have Driver James Macdonald in for film review on Monday.

R4 – Reviewed racing in the stretch, #1 Points North (Jonathan Drury), (finished ninth and was placed tenth) comes out and hooks the wheel of #3 The Greek Freak (Tyler Jones), (finished tenth and was placed ninth).

R5 – Reviewed racing in the stretch between #2 Iris Seelster (Jody Jamieson), (finished third) and #7 Kele Kele (Travis Henry), (finished second). #2 and #7 touch forks briefly, there were no violations.

R6 – Reviewed racing before the half. #2 Unison (Jody Jamieson), (finished seventh and was placed eighth) makes a break and causes interference to #1, #7 and #9.

R7 – All clear.

R8 – The Judges spoke to driver Doug McNair (#5 Hungry Man), (finished first) about the fractions in this race, opening quarter in 26.4 with a half in 57 (30.1 second quarter). There was no confusion going to the half.

R9 – All clear.

R10 – All clear.

R11 – Recall on #6 Highlandbeachbest for broken equipment (hopple hanger).
