### Backstretch:

Jockey David Moran excused from his mounts today.

Jockey Juan Crawford issued a five-day riding suspension, August 31 through Sept. 4, 2023 from Race 10 on August 6, 2023. Ruling forthcoming.

Race 7, August 13, 2023. Sahin Civaci and Rafael Hernandez, Daren Gomez as rep. Mr. Civaci levied a three-day riding suspension. Days to be determined

### Races:

72 Entries

Race 1, #8 Walter Me Lad bore out at start, wind played a factor for horses in the stretch. Rest ok

Race 2, Inner Turf, #1 Sharp Aza Rainbow, on advisement of the Official Veterinarian was scratched, refund of \$12,818. Stewards Inquiry and Jockey claim of foul, #2 S. Chernetz, 4<sup>th</sup> on #3 R. Walcott, 3<sup>rd</sup>, through stretch. Upon review of upper pan and front tower camera angles #2 is trying to angle out for running room, #3 holding her in, gets tight make contact, bounce off each other and #3 comes in strongly where #2 has to check. #3 finished 3<sup>rd</sup> placed 4<sup>th</sup>. Notice of review for Walcott and Chernetz.

Race 3, All clear

Race 4, EPT Turf, #4 Holiday in Chile off slow and bore out slightly, #10, fractious before the ¼ and bore out, #9 lacked room through stretch, rest ok

Race 5, #2 Chipotle Pepper very light mouthed at the break and the run into the far turn.

1<sup>st</sup> inquiry, Jockey claim of foul, #1 J. Crawford, 5<sup>th</sup>, on #3, D. Carroll, 1<sup>st</sup> after the start,

2<sup>nd</sup> Inquiry, #5, R. Walcott, 7<sup>th</sup>, on #3, D. Carroll, 1<sup>st</sup>, stretch run.

Inquiry #1, review of back tower and upper pan camera angles, #3 is forced over from outside horses causing #1 to lack room on the inside forcing Crawford to check. Disallowed

Inquiry 2, #5 is on the inside, #3 goes for clear running room of #4, does come in but is running by #5, Walcott does steady his horse, Carroll felt he was clear. Claim of foul disallowed

Race 8, Stewards' Inquiry, #3 Sixtofive unseated Jockey Amanda Vandersmeersch deep stretch, upon review of the front tower and upper pan camera angles, #1 O. Moreno, 4<sup>th</sup>, is drifting out into the path of #3, causing that one to clip a heel and Vandersmeersch is unseated. #1 finished 4<sup>th</sup> placed 8<sup>th</sup> and disqualified. Notice of review for Moreno.
