Heavy rain overnight has led to the races, scheduled for turf, to be removed and will run at the distances required on the main track.

Trainer Jeff Voyce enquired about his horse in tomorrow's 4th race, Bala Falls. Has a skin condition that is currently an issue and asked for the Official Veterinarian to observe the horse. Dr. Kretzshmar did observe the horse and on advisement of the Veterinarian the horse to be scratched. The horse will be placed on the Veterinarians' list, ineligible for 7 days.

Jockeys, Jodiene Anderson and Jason Hoyte excused from their respective mounts today. Jockey Jefferey Alderson excused from his mount in the first race. Will be aboard the remainder of his mounts.
