

Race 1, Off turf, #4 I'm Into Mischief took an awkward step off the start and did not finish. Spoke with Jockey Flores who confirmed same. Rest ok.

Race 2, Inner turf, All clear

Race 3, Off EPT Turf, Lake Superior Stakes, #3 Sooner Lunar leapt up and out at the start, rest ok.

Race 4, Inner Turf, All clear

Race 5, ,#1 Paintthetownsilver, off a step slow, prevailed. Reviewed racing at the top of the stretch. #1 Paintthetownsilver, S. Civaci, 1<sup>st</sup> and #7 Motskari, J. Hoyte, 7<sup>th</sup>. #1 does bare out at the ¼ pole but is clear of #7 as they are both wide through stretch. Rest ok Jockey R. Hernandez, #3, was unseated galloping out after race, checked and cleared by EMS.

Race 6, off EPT turf, Thunder Bay Stakes, #1 Souper Sinclair stumbled after the start. Reviewed racing down the backstretch, #3 Souper Sunday is in tight, does steady as room diminished in between horses, #2 Anam Cara is tight to the rail, also steadies going into the turn, no violations. Rest good

Race 7, #8 Spanish Serenade popped up slightly at start, #10 Smokin Holiday bore out at start, rest good,

Race 8, Inner Turf, All clear

Race 9, off EPT Turf, On advisement of the Official Veterinarian, #1 Celentano was scratched in the paddock, refund \$8,300.00

Jockey claim of foul, #4 K. Nicholls aboard Wicked Django, 2<sup>nd</sup> on #8, E Wilson aboard Ready Shakespeare, 1<sup>st</sup> going into the far turn. Upon review of the upper pan, back tower and apex camera angles, #4 is inside going into the turn #8 is going by #4, Nicholls does check his mount but there is room inside for him. Claim of foul disallowed.

Race 14, Inner Turf, Stewards Inquiry and Jockey claim of foul, #1, S. Chernetz, 3rd on #4 L. Salles, 1<sup>st</sup> going into the clubhouse turn.
