After review of the upper pan and front tower camera angles, there is no evidence to support any interference from #3 as it maintained a straight course as #6 moved slightly to its right catching a heel and falling. There was no change to the order of finish. Jockey K. Kimura was transported to outside ambulance services and was removed from the remainder of his mounts and entered concussion protocol. TB Ruling #2253028. Jockey Rico Walcott was also excused from the remainder of his mounts. Rest ok
