# Film Reviews:

Race 4, July 8, 2023 Leo Salles, hand above shoulder height when urging. Mr. Salles explained that his horse was lugging in through the stretch and he was trying to stop from hitting the fence, the bridle that was on the horse did not help in steering. Mr. Salles' explanation was satisfactory that his actions were in the spirit of safety and issued no penalty.

Race 1, EPT Turf, #1 Four K Force and #2 Seattle Down Under off a step slow, reviewed run around far turn #1 Four K Force, A. Vandersmeersch, 5<sup>th</sup>. Was lugging out forcing her to take a hold, #4 Street Serenade took a few rough steps around the far turn. Rest ok.

Race 2, Jockey claim of foul, #6, Jason Hoyte, 2<sup>nd</sup> on #1, Jose Campos, 1<sup>st</sup> around the sixteenth pole. Upon review of the upper pan and front tower camera angles, Mr. Campos is angling in from the outside to #6, #5 is inside and comes out a step but there is no break in momentum of either rider. The claim of foul was disallowed.

Race 3, All clear

Race 4, Reviewed run after the start, #7, S. Vives, 1<sup>st</sup> and #4, Golden Burn, Flores, 8<sup>th</sup>, spoke with apprentice jockey Sofie Vives to leave room when dropping down after the start. Race clear. #3 Legal Catch was eased at the top of the stretch and galloped past the finish.

Race 5, EPT Turf, Stewards Inquiry, stretch run #5, Seattle Causeway, J. Anderson, 1<sup>st</sup> and #7, Bequia, L. Contreras, 3<sup>rd</sup>, Jockey claim of foul, #7 on #3 top of stretch, Jockey claim of foul, #2 Cloud Storage, S. Civaci, 2<sup>nd</sup>, top of stretch on #5. Upon review of the upper pan and front tower camera angles, #5 is not clear as he moves laterally left forcing #7 to check hard. The #2 did not appear to be affected by the action and that claim of foul was disallowed. The Jockey claim of foul from #7 and the Stewards' inquiry were upheld. #5 Seattle Causeway was disqualified from 1<sup>st</sup> position and placed 3<sup>rd</sup> for interference to #7.
