Jockey Howard Newell excused from his mount today.

Call to trainer Claudia Rabstein, informed of the horse Natural Habitat which participated in the 6th race June 15, 2021. Natural Habitat placed 2nd Horse participated on the medication Furosemide (Lasix) when not enrolled to the EIPH program in Ontario. Horse is disqualified, TB Ruling #1235290, and all purse monies to be returned and redistributed according to the revised order of finish. trainer Claudia Rabstein assessed a \$200.00 monetary penalty.

Trainers Anthony Alderson (TB Ruling #1235212) and Thomas Steer (TB Ruling #1235143) both issued a \$200.00 monetary penalty for having entered ineligible horses necessitating scratches from the 8th race today.

Race 6, June 15, 2021. Ademar Santos, Horse Trail Blazing Essa. Was disqualified in 1st placed third for interference at the start. Was not able to review but an offer to send the video via email link. After discussion, no penalty assessed for Mr. Santos as it was first jump.
