

Race 1, #1 Sneaky Rebel knuckled over at the start, rest ok

Race 2, All clear

Race 3, reviewed run around the 1/4 with #4 Joe Chrome, D. Bynoe, horse was in the middle, room diminished, no violations. Rest good.

Race 4, Turf, #4 Amen To That and #5 Core, on advisement of the Official Veterinarian, were both scratched at the gate, #4 reared and was lodged underneath, the #5 sustained an injury from the #4 as a result. Complete refund of \$128,769.

Stewards' Inquiry, far turn, #3 Autumn's So Flashy, 2nd, B. Boulanger and #6 Tipa Frost, 6th, L.

Seecharan, Upon review of back tower, upper pan and apex camera angles, #3, inside, is lugging out and forces the #6 to check hard and lose momentum in the middle with #8 outside, #3 finished 2<sup>nd</sup> placed 6<sup>th</sup> for interference.

Race 5, #4, Doodle Dandy, fractious just before the break, left flat footed and slow, #7 Awildas Treasure slight stumble at start, rest ok

Race 6, #2, Rockland Express bore out and slow at start, rest good.

Race 7, Trainer Julie Mathes reminded to have her horses in the paddock at the appropriate time. Turf, #6 Ace Destroyer and #7 Executive Giant, on advisement of the Official Veterinarian, were scratched at the gate. #7 was fractious and the #6 was subsequently scratched as a result. Refund of \$46,388. Race All clear
