Race 1, Inner turf, All clear. Utilized the upper pan camera angle shot for the official order of finish as the operator of the photo finish camera had the camera for photo set on the Tapeta course.

Race 2, EPT Turf, #7 Ready Hero off a step slow, rest ok

Race 3, All clear

Race 4, EPT Turf, Woodbine Turf Endurance series, reviewed top of stretch, #4 S. Jones, 6<sup>th</sup>, and #5 J. Hoyte, 9<sup>th</sup>, #4 does come across the path of #5, and #5 steadies a step, no placings required. Spoke with S. Jones, make sure to be clear when moving out.

Race 5, Inner Turf, All clear

Race 6, #5 Glenholme was eased through the stretch, rest ok

Race 7, EPT Turf, #2 Breaking Alone and #6 Ron's Gizmo both off a step slow, #2 prevailed. Reviewed stretch run as some horses lacked racing room as they were all tight on the rail, no placings required.

Race 8, on advisement of the Official Veterinarian #9 Dotted Line was a late scratch, #7 Decimator had a troubled start, rest ok.

Race 9, EPT Turf, Breeder's Stakes, Stewards' inquiry and Jockey claim of foul #8, Duke of Love, J. Stein, 7<sup>th</sup> and #7 Dancin in Da'nile, R. Hernandez, 4<sup>th</sup>, top of stretch. Upon review of the front tower and the upper pan camera angles, #7 does come in a couple of paths down to the #8, J. Stein does have to check his mount and is forced over heels of the inside horses. #7 finished 4<sup>th</sup> and was subsequently disqualified and placed 7<sup>th</sup>. NOR for Hernandez and Stein.
