

Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

Call from trainer Darren Glennon. Stated he had entered two horses for Thursday in which only one did get in a race which filled. After speaking with the Race Office the entry is not covered under TB Rule 6.39 and was not allowed to be added to the field in the fourth race on Thursday.

Races:

98 Entries

Race 1, Inner Turf, All clear

Race 2, Jockey claim of foul, #1, Ann of Cleves, K. Nicholls, 5th, on #7, Lady Maeve, S. Jones, 3rd, going into the far turn. Upon review of apex, back tower and upper pan camera angles, it was inconclusive to the interference as it appears Mr. Nicholls' horse may have been laying out into

the turn. Mr. Nicholls felt the #7 came over quickly and he had to check hard, stated that his horse was not laying out. Mr. Jones felt he was clear of him. Claim of foul was disallowed.

Race 3, Inner Turf, Woodbine Cares Stakes, All clear

Race 4, on advisement of the Official Veterinarian, #8 She's Loaded was scratched, Reviewed the run down the backstretch, #5, Sonet's Name, 7th, L. Contreras, steadies a step as #6 is moving towards the rail. No placings required. Rest ok.

Race 5, EPT Turf, #7 All My Tomorrows stumbled start, Rest ok.

Race 6, All clear

Race 7, EPT Turf, Nearctic Stakes, All clear

Race 8, Durham Cup Stakes, All clear

Race 9, EPT Turf, E. P. Taylor Stakes, Stewards' Inquiry and Jockey claim of foul, #7, Lemista, L. Contreras, 8th on #3, Moira, R. Hernandez, 2nd. Through stretch. Review of upper pan and front tower camera angles shows #3 dive for a spot on the inside but is not clear of the #7 when doing so. #7 has to check hard and loses all momentum. #3 finished 2nd and subsequently placed 8th for interference in the stretch.

Race 10, #9 Field Hockey delayed in paddock for a shoeing correction, #3, Ninety-Four Expos was a late Steward scratch due to running off during warm-up. (Refund \$75,294) All clear
