Stewards' Inquiry, #5 Keen Samurai at the start, was deemed to have received an unfair start and a complete refund was ordered. Refund \$20,746. Rest ok. Jockey Keveh Nicholls excused from the remainder of his mounts.

Race 7, Stewards Inquiry and Jockey claim of foul, #5, MLee Buchanan, 2<sup>nd</sup> on #6, M. David, 1<sup>st</sup> after the start. Upon review of the back tower and upper pan camera angles, #6 does bare out at start and drifts down to the inside towards #5, #5 does come out slightly to the #6 path and shies away from the #6 and the #5 steadies. After review of the incident and speaking with the riders, the claim of foul was disallowed.
