**Races:**

**R1 – INQUIRY.** Reviewed the start where #1 Burlesque Seelster (C. Kelly, 3<sup>rd</sup>) goes off stride briefly, loses ground, and does not interfere with the trailing horse. Race Officials spoke to driver Garret Rooney, #8 Anchor So Reel, who confirmed their observations. All races are being hand timed today.

**R4 – Reviewed racing at the 1/2 where #2 Century Rock (T. Borth, 3<sup>rd</sup>) appears to be flushing out cover from #4 Silver Sea (Tra Henry, 4<sup>th</sup>). No violation.**

**R5 - #4 Arroyas Luck (C. Kelly) was off the gate from the start, trailed the field, pulled up after 3/4 and did not finish. #8 Pull the Gate (T. Borth) also pulled up after 3/4. As a result**

of their poor performance both horses must qualify to race again. The Paddock Judge was notified.

**R8** – Following this race the final standings of the Drivers Championship were announced. All driver earnings in R1 through R8 were donated to the Royal Canadian Legion:

**R9** – OSS 1<sup>st</sup> Division. Reviewed racing in the stretch where #3 Lite the Candles (B. McClure, 5<sup>th</sup>) goes off stride for less than 25 strides, loses ground and does not cause any interference. No violation. #5 Jeronimo (C. Kelly) finished well back (greater than 35 lengths) and must qualify for performance. The Paddock Judge was notified.

**R10** – OSS 2<sup>nd</sup> Division. INQUIRY. Reviewed all horses off stride. #2 Stonebridge Jasper (C. Kelly) finished 5<sup>th</sup> and was placed last (8<sup>th</sup>) for an extended break exceeding 25 strides from the starting point and into the first turn.
