**R3** – 1<sup>st</sup> Elimination – INQUIRY. Reviewed pylons in the first turn when the inside wheel of #1 Alexander (M. Bax, F2) does go over one pylon and inside one pylon. No violation of the <u>pylon rule 18.08.02.</u>

**R4** – INQUIRY. Reviewed racing in the stretch when #1 Rylentless (T. Borth, F3) tries to get up the inside when there is not enough room. #1 does make contact with the winner's wheel and is charted with interference (I). No placing required. #5 Acefortyfour Jack does

go off stride after the 1/2 and must qualify for consecutive breaks on fast tracks. The Paddock Judge was notified.

R5 – Clear

 $R6 - 2^{nd}$  Elimination. Reviewed racing after the 1/2 when #5 Brutalizer (Tre Henry, F6) does go off stride. No violations.
