## Races:

R1 – Elimination #1 – Clear

**R2** - #7 Always Been Crazy (C. Kelly) made a break before the 1/2 and pulled up before the 3/4 pole. The driver reported that the knee boot got caught up in the hopple. #7 was charted with an equipment break (EX). Driver Sylvain Lacaille finished 2<sup>nd</sup> and was contacted about excessive urging in the stretch. Judges will follow up.

**R3** – The track was upgraded to "Fast" before the race. Clear.

**R4** – Elimination #2 – INQUIRY. Going into the first turn #2 Stonebridge Bomber (J. Drury, F2) goes off stride, causing interference to #5 Century Jeanie (L. McClure, F5). Drury said #3 on his outside caused the interference but the film does not support this. #2 was 2<sup>nd</sup> placed 5<sup>th</sup> for causing interference while off stride. Driver Jonathan Drury and assistant trainer Chris Matthews gave verbal intent to appeal the placing.

R5 - Clear

**R6** – Reviewed racing before 3/4. The upper pan and back tower cameras show that #1 has room to pull out while #5 is advancing. Driver Austin Sorrie on #5 said it was tight but that his horse is also green. No violation.

**R7** – Elimination #3 - Late driver change from Jody Jamieson to Paul MacKenzie as Jamieson was delayed by traffic. Reviewed #5 Rough Tuff Tested (J. Drury, 5<sup>th</sup>) who went off stride in the stretch. No violation of the breaking rules.

**R8** - #2 Wheelygoodrinker (R. Waples Jr.) did go off stride before the 1/4 and must qualify for breaks in consecutive races on a fast track.

R9 - Clear

**R10** – Reviewed the break of #8 Allbetsonfritz (T. Fritz, F6) in the first turn. All horses got around him ok.
