**Races:**

R1- Clear

R2 – Clear

R3 – Reviewed the start of the race where #6 Country Charm (Tra Henry, 8<sup>th</sup>) goes off stride before the start but is inside the fair start pole. No violation.

R4 – INQUIRY. Starting from the finish line back, #2 Danish Brew (T. Borth, 4<sup>th</sup>) goes off stride at the head of the stretch while sitting second and uses the safety lane to get out of the way and get his horse back on stride in under 25 strides. He re-enters the track in fourth place and follows all breaking rules. No violation. Reviewed racing at the start where #1 Royal Tea (B. Moore, 5<sup>th</sup>) goes off stride briefly, is off the gate, but is inside the fair start pole. No violation. Also reviewed #6 and #7 making multiple breaks.

#6 Somethingaboutlucy must qualify for breaks. The Paddock Judge was notified.

R5 - #4 Fear the Captain, 3yo, finished the pace in 205.2 and must qualify. The Paddock Judge was notified.

R6 – Reviewed racing going to the 1/4 where #5 Atlas Marigold (N. Macinnis, 5<sup>th</sup>) makes a short break and causes interference to the winner #3 Rylentless. No placing required. #5 is also due to provide a negative Coggins test to Standardbred Canada before its next start. When the race was over the Official Vet added #1 Curious Bubbles to the Vet List, short-term lame.

R7 – INQUIRY. Starting from the finish line back, #1 Downstairs Party (R. Holiday, 5<sup>th</sup>) goes off stride for less than 25 strides and loses ground to the field. No violation. #2 SG Goliath King (T. Borth, 4<sup>th</sup>) goes off stride after the start. No violation.

R8 – Reviewed racing at the head of the stretch where #4 Azucar Pipedream (T. Borth, 4<sup>th</sup>) goes inside one pylon and does not gain an advantage. No violation.
