Office:

The Judges did have a paddock meeting to review Standardbred rules 6.54.01 and 6.54.02 which come into effect on January 1, 2024. These rules relate to the out of competition testing of horses after a qualifier. This testing will be looking for any Analgesic, Corticosteroid, Anti-inflammatory, NSAID or local anesthetic. Also, substances that belong to the classes of drug that do not have an elimination guideline. As a reminder, horses qualifying to come off the long-term vet's list will continue to be tested, as they have been since June of 2023.

Ruling #2480466 generated, Nicholas Steward did fail to drive "Play N Bad" in race #3, violation of AGCO rule 6.02(a). Mr. Steward issued a \$100.00 monetary penalty.
