**Race 3 – #1 "Match Meif You Can" (M. Bax) finished 7<sup>th</sup> placed 8<sup>th</sup> for an extended break in stride.**

**Race 4 – "Inquiry" 1<sup>st</sup> turn #2 "A Bit A Billie" (Borth 4<sup>th</sup>), gets rough but does not make a break in stride. #4 "OldfriendsKentucky" (Wray 3<sup>rd</sup>) appears clear when he crosses over to the front. No change to the order of finish.**

**Race 5 – #8 "Lucy Who" (Renaud 8<sup>th</sup>) makes a break in stride at the top of the homestretch, interference charted on #2 "Enola" (Borth 2<sup>nd</sup>).**

**#1 "Decadent Seelster" makes a break after the ¾ pole, placed on the Judges List, and must qualify for "breaks" (trainer Richard Moreau).**

**#7 "Priceless Resolve" makes a break in stride before the ¾ pole, placed on the Judges List and must qualify for "breaks" (trainer John Bax).**

**Race 6** – #6 “Controlthelightnin” makes a break in stride going to the ¼ pole, interference charted on #7 “TJ Thunder”. #6 finished 7<sup>th</sup> and placed 8<sup>th</sup> for causing interference while off stride.

**Race 7** – #6 “Mostly Dali” (Rooney, 1<sup>st</sup>) finished with broken equipment (knee boot)
