**Race 1** - Clear

**Race 2** – Clear

**Race 3** – Clear

**Race 4** – Reviewed going to the ¾ pole #7 "Western Wish" (Roy 3<sup>rd</sup>) does have clearance when moving off the rail.

**Race 5** – Paul MacDonell ("Illgetmyown Thanks") was issued a warning for his urging (more than acceptable wrist action) in the stretch, entered iAGCO.

**Race 6** – Reviewed after the start #1 “Windsun Tiara” (MacDonald) just gets rough, no break in stride.

**Race 7** – Clear

**Race 8** – Reviewed going to the 1/2, #4 “Save America” (Gingras, 2nd) is three wide, leaving #2 “Stockade Seelster” (Jamieson 1<sup>st</sup>) sufficient room to drive between horses.

Reviewed going to the ¾, #3 “Tip Top Cat” (McNair, 6th) moves back to the rail and has clearance of #6 “Ants Marching” (McCarthy 9<sup>th</sup>) .

In the stretch #6 makes a break in stride, interference charted on #10 “Gung Ho” (Miller 8<sup>th</sup>), no placing needed.

**Race 9** – “**Inquiry**” top of the stretch #5 “Slay” (Bongiorno 1<sup>st</sup>) makes a break in stride, does lose ground and does not interfere with any other horses, no violation of the breaking rule. #5 Did not go inside any pylons. No change. <https://youtu.be/IOTc4Mhuewc>

#7 “Branded By Lindy” (Gingras 9p11p10) made a break in stride past the ½ and placed for an extended break in stride.

#4 “Twin B Archie” (MacDonald 11p10p11) made a break in stride after the start and placed for an extended break in stride.

#8 “Duly Resolved” (MacDonell) made a break in stride before the start and was well inside the fair start pole.

**Race 10** – Reviewed the breaks in strides on #4 “Yo Beth D” (Miller 10<sup>th</sup>) and #6 “Winners Bet” (Dunn 9<sup>th</sup>), no placings needed.
