Ruling Number SB ADMIN 40/2019

TORONTO, ONTARIO - December 12, 2019

IN THE MATTER OF THE HORSE RACING LICENCE ACT. 2015; S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF STEPHANIE JAMIESON, LICENCE NO. Z03963

On September 9, 2019, the standardbred horse "ATLANTIS" (freeze brand # 3P726) finished SIXTH (6^{TH}) in the eighth (8th) race at Mohawk Raceway. "ATLANTIS" is trained by STEPHANIE JAMIESON "JAMIESON".

On September 12, 2019 Racing Forensics Inc. reported that the blood sample with Test Tag number 531925215, contained TC02 with a value measured of 38.0 mmol/L.

TAKE NOTICE that based on the above JAMIESON is found to have violated 22.38(a), 26.02.01, 26.02.02 and 26.02.03 (d) of the Rules of Standardbred Racing.

Accordingly, pursuant to the authority under 6.01, 6.04, 9.08.2 and 22.38.06 of the Rules of Standardbred Racing and Policy Directive 1-2018, JAMIESON is hereby fully suspended for FORTY-FIVE (45) days (December 12, 2019 to January 25, 2020, inclusive) and issued a monetary penalty of TWENTY-FIVE HUNDERED dollars (\$2,500).

In accordance with Alcohol, Gaming and Racing Standardbred Rule 18.08.01, "ATLANTIS" is hereby declared disqualified for all purposes, with the exception of Pari-Mutuel Wagering. The revised order of finish for Race 8 at Mohawk Raceway on September 9, 2019 is as follows:

ATLANTIS - disqualified

The following terms are added to JAMIESON's license: two years of probation commencing (January 26, 2020 to January 25, 2022, inclusive), pursuant to Rule 6.01 (d) of the Rules of Standardbred Racing and Policy Directive No. 3-2008.

The Licensee shall keep the peace and be of good behaviour; 1.

The Licensee shall allow Commission Inspectors access to his stabling area at any time to 2. conduct unannounced random searches for illegal or non-therapeutic medications or drugs;

The Licensee shall allow commission inspectors to seize any illegal or non-therapeutic 3. medications or drugs found at his stabling area; 4.

The Licensee shall be subjected to the AGCO's Out of Competition Program; and

The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed 5. by the AGCO Judges for any breach of the terms of their license.
