Woodbine Racetrack

IN THE MATTER OF THE *HORSE RACING LICENCE ACT, 2015*,

S.O. 2015, c.38, Sched. 9;

AND IN THE MATTER OF *Stuart C. Simon*

On September 29, 2020, Bureau Veritas Canada issued a certificate of positive analysis, from a urine sample, test tag #73 20257 321, for the Class IV medication Betamethasone. The sample was obtained from the horse, "Pipestone", owned by Chiefswood Stables and trained by Stuart SIMON, which finished third in the fourth race at Woodbine racetrack on September 13, 2020.

TAKE NOTICE that Trainer Stuart SIMON having accepted the settlement agreement, is hereby issued a suspension of three calendar days, October 11, 12, and 13, 2020, and a monetary penalty in the amount of \$500.00, payable at the termination of the suspension. The suspension of Mr. SIMON is effective for horses racing in The Province of Ontario and during the suspension is denied access to any Association grounds with the exception of grandstand privileges. Any horses that are to be entered to race or trained by Mr. SIMON during the suspension, must be transferred to another trainer in good standing and approved by the Stewards. In accordance with AGCO TB Rule 15.04.03, the horse "Pipestone" is hereby unplaced from the fourth race at Woodbine on September 13, 2020 for all purposes with the exception of pari-mutuel wagering.

The revised order of finish for the 4th race on October 13, 2020, shall be as follows:

- 1st- Capable
- 2nd- Sky Dragon
- 3rd- Delightful Dreamer
- 4th- Lean On E
- 5th- All Eyes On Me
- 6th- Play It Smart
- 7th- Call Her Joey
- 8th- Alittleirishluck

Pursuant to Policy Directive 3 - 2008, Stuart Simon has the following conditions placed on his license for a period of two years, October 14, 2020 through October 14, 2022.

1. The licensee shall keep the peace and be of good behavior.
2. The licensee shall allow AGCO Compliance Officials access to his stabling areas at any time to conduct unannounced random inspections.
3. The licensee shall allow AGCO Compliance Officials to seize any items of concern to the best interests of racing.
4. The licensee shall be subject to the AGCO out of competition testing program.
5. The licensee may be subject to a Notice of Proposed order in addition to any penalty imposed by AGCO Racing Officials for any breach of the terms listed.
