Backstretch:

- Test strips were utilized in races one and three.

Race 1:

- #5 Wahrer Schatz (Sahin Civaci), (finished first) popped up at the break but prevailed.

Race 3:

- #3 British Crown (Emma-Jayne Wilson), (finished fourth) was away slow.

- Prior to the race there was a delay for maintenance to the starting gate.

Race 8:

- Stewards Inquiry and Jockey claim of foul X2, both incidents happened in the stretch.

First Inquiry and Jockey claim of foul, #8 Happy Valentine (Sahin Civaci), (finished third, placed second) on #2 Pleasure's Gold (Rafael Hernandez), (finished first). #2 brushes the #8 as he goes by with incidental contact. Jockeys claim of foul #8 on #2 was disallowed.

Second inquiry and Jockey claim of foul, #6 I'm Into Mischief (Eswan Flores), (finished eighth, placed seventh) on #1 Hai Bobbi (Sofia Vives), (finished second, placed eighth). #6 is between horses as the #1 drifts out to the #6 causing the #6 to check. The Jockeys claim of foul #6 on #1 was upheld. #1 finished second and was placed eighth for causing interference to #6 in the stretch. Notice of review was sent to Jockey Sofia Vives.
