

 The photo finish equipment did not function properly for this race. There was nothing close that required a photo.

Race 2:

Race 3:

- #4 Ivy's Star (Skye Chernetz), (finished first) was away slow but prevailed.

Race 4:

- #11 Fourteen Days (Christopher Husbands), (finished tenth) broke outwardly.

Race 5:

- #4 Pemberley (Kazushi Kimura), (finished second) stumbled on the break.

Race 6:

- All clear

Race 7:

- Two Stewards Inquiries and two Jockeys claim of fouls.

First Inquiry and Jockeys claim of foul #5 Bet N Win (Luis Contreras), (finished fourth placed third) on #4 Midway Mischief (Slade Jones), (finished first placed fourth) in the vicinity of the quarter pole. #4 is behind horses and pushes his way out to the #5 putting the #5 on the heels of #6 Jimmies Big Day (David Moran), (finished fifth), causing the #5 to check.

Second Inquiry and Jockeys claim of foul #1 Classy Whisper (Kazushi Kimura), (finished third placed second) on #4 Midway Mischief (Slade Jones), (finished first placed fourth) in the stretch. #4 comes down to the #1 in the stretch causing the #1 to check.

The #4 finished first and was placed fourth for causing interference to #5 in the vicinity of the quarter pole. The #4 does interfere with the #1 in the stretch but no placing was required.
