## Adding or Removing a Horse from the EIPH Program

**Important  
to note!**

- Horses whose last race line (past performance) was outside of Ontario showing the horse competed on Lasix will be automatically enrolled into the Ontario EIPH program (no regulatory submission is required to be in iAGCO). To opt out of the Ontario EIPH program a regulatory submission must be made by time of entry for such horses (shipping into compete with last race showing the horse competed on Lasix).
- A Veterinarian/Trainer/Assistant Trainer/Owner must upload the required forms with the signature of an attending veterinarian and signature of trainer before the submission can be completed.
- A horse must be enrolled in the EIPH Program by the time of entry.

You are required to add or remove a horse from the EIPH program online using the iAGCO portal at [www.agco.ca/iagco](http://www.agco.ca/iagco). To use iAGCO, you must have an iAGCO account.

### How to create your iAGCO account

1. If you do not already have an iAGCO account, go to iAGCO at [www.agco.ca/iAGCO](http://www.agco.ca/iAGCO)
2. Click on **Create a New Account** at the top of the page to create your account  
**Note:** You must have a valid email address to create an account
3. Input all of the information requested on the screen
4. To link your account to an existing AGCO licence, you will need to enter an access code  
**Note:** You can also call AGCO Customer Service during regular business hours at 416-326-8700 or toll-free 1-800-522-2876 or ask a AGCO Licensing Agent at any open track office to request an online access code
5. After you click on **Finish Registration**, go to your email inbox and click on the verification link in the confirmation email sent by iAGCO to complete the account registration process

### How to add or remove a horse from the EIPH program

1. Click on the **Regulatory Submission and Notifications** link displayed under the **Additional Options** section on the Main menu page  
**Note:** If you want to Opt-out of the EIPH program, you will need to make a Regulatory Submission in iAGCO called **EIPH Program - Horse Opt-Out (Shipping in to Compete in Ontario)**
2. Select **NEW > EIPH Program - Add or Remove Horse (Ordinarily Competing in Ontario)**
  1. Proceed through all of the screens and answer all of the questions
  2. Upload the required forms signed by the horse's attending veterinarian (A signature by the official vet is no longer required) and the trainer  
**Note:** You can either open and download the Sample Forms to your computer first (File -> Save as), obtain the required signatures, then scan and upload or get the printed forms from a Licensing Agent at any open track office.
3. Proceed to read the declaration on the following screen and click Submit
