IN THE MATTER OF THE HORSE RACING LICENCE ACT, 2015, S.O. 2015, c.38, Sched. 9; AND IN THE MATTER OF TYLER NOSTADT

On August 18, 2022, the Alcohol and Gaming Commission of Ontario "AGCO" was advised of a positive reading for the Class 5 drug furosemide quantified at 167 ng/ml, in the blood sample Test Tag 44 22219 304E. The sample was obtained from the Standardbred horse, "PAPARAZZI HANOVER", (tattoo #3K891), which finished first (1st), in the tenth (10th) race on August 7th, 2022 at Leamington Raceway. PAPARAZZI HANOVER was trained by Tyler Nostadt, "NOSTADT".

TAKE NOTICE that based on the above NOSTADT is found to have violated 9.09(b), 26.02.01, 26.02.02 and 26.02.03(c) of the Rules of Standardbred Racing. In accordance with 6.04, 9.08.02 of the Rules of Standardbred Racing and Policy Directive 1-2018, NOSTADT is hereby fully suspended for six months and issued a monetary penalty of FOUR THOUSAND dollars (\$4,000.00). As NOSTADT is not currently licensed, the suspension shall commence on a date to be determined by the Director.

TAKE NOTICE that all horses owned in whole or in part are suspended and are not eligible to race during the suspension period. All horses may with the consent of the AGCO Racing Officials be released to another trainer in accordance with Rules 6.13.01 and 26.08. All purse monies shall be returned for redistribution. In accordance with Rules 9.13 and 18.08.01, PAPARAZZI HANOVER is hereby declared disqualified for all purposes with the exception of Pari-Mutuel Wagering and all purse monies must be returned. The revised order of finish for Race 10, at Leamington Raceway on August 7th, 2022 is as follows:

4th #2 Silver Sandy

#1 PAPARAZZI HANOVER – disqualified

The following terms are added to NOSTADT's license: two years of probation commencing on a date to be determined by the Director as NOSTADT is not currently licensed, pursuant to 6.04 of the Rules of Standardbred Racing and Policy Directive No. 3-2008:

- 1. The Licensee is required to complete the AGCO Equine Medication Use and Awareness Program before reinstatement;
- 2. The Licensee shall keep the peace and be of good behaviour;
- 3. The Licensee may be subject to a Notice of Proposed Order in addition to any penalty imposed by the AGCO Race Officials for any breach of the terms of their license.
