We advised that the horse would be scratched to avoid any further issues, however, this is considered a Stable error necessitating a scratch which carries a monetary penalty of \$300.00. Review of yesterdays third race involving Justin Stein, Leo Salles and Slade Jones, Daren Gomez was also present. Justin said he was on the fence when the two outside horses dropped in on him, hit the fence pretty good. Leo said Slade came over on him and pushed him into Justin, said he could help him on the fence. Slade said he felt the horse in front of him maybe dropped in a bit but said he got confused at the time. After review, it was decided the incident warranted a three day riding suspension, days to be determined.
