

Review of Sunday October 11, race 5 involving Justin Stein and Luis Contreras and a separate incident in the same race with Jerome Lermyte and use of his crop. Irwin Driedger and a journeyman rider were present for both reviews.

Jerome uses his crop in the overhand or cocked position five times through the stretch. Jerome said his horse was lugging in with him and he used it for safety reasons. Jerome was handed a third offence violation penalty of a three day riding suspension and \$500.00, days to be determined.

Justin and Luis, Luis said Justin came over on him and put him in a bad spot, had to check. Justin said he went for the hole when the horse in front came in, it was a combination and Luis took the worst. Said he should have claimed foul on the horse in front. After discussion it was determined that Justin be levied a three day suspension, days to be determined.
