

Race 4 – Stewards Inquiry and Jockey Claim of Foul (COF) by Luis Contreras aboard #6 "Ephrata" which finished fifth against #10 "Destinique" with Sahin Civaci who finished fourth for interference during the stretch run. Luis said Sahin was laying on me and he almost came in front of me, don't know why he would do that. Sahin said Luis was pushing out on the turn and we did come together at the top of the stretch but you can see he is pushing out and I'm just trying to hold my ground. He eventually pushed the back end of my horse out which turned my horses

head inward making it look worse. After review, the COF was disallowed.
