RACES

Race 1 – Reviewed racing in the stretch between #6 Like Chaos (Trevor Henry) and #8 Southwind Coors (Chris Christoforou) – front tower shows there is no interference by #8 on #6.

- Chris Christoforou – failed to keep both feet in the stirrups – \$300 monetary penalty and 5-day driving suspension (April 3–7), AGCO Rule 22.19 (second offence within one year), Ruling #2592796.

- Reviewed the break by #7 Jokic (Sylvain Filion) before the start – horse was well inside the Fair Start Pole.

Race 2 – Reviewed pylons on #6 Frownies Miracle (Trevor Henry) at the top of the stretch, finished 4th – horse races inside one pylon; no violation of the AGCO pylon rule.

Race 3 – Reviewed the breaks by #1 Buck Dancer (Jonathan Drury), #3 Mrmayor Hanover (Sylvain Filion), and #7 Distance Learning (Austin Sorrie) – no violations of the AGCO breaking rule.
