Race 1 – All Clear

Race 2 – All Clear

- A claim entered on #8 Real Surreal was voided as it was late (28 minutes).

Race 3 – Inquiry – Reviewed the break by #3 All Cheddar (Mike Saftic) after the start. The video shows #3 bears out slightly while #11 Jim Blue (Trevor Henry) is coming down, which causes #3 to make a break. Judges felt it was 50/50 between the two horses and that #1 Jimmy Connor B (Doug McNair), who was along the inside, did not contribute to the incident. No placings were necessary; #3 was charted with an 'ix'.

Race 4 - Reviewed the stretch - #6 Major Hill (Doug McNair) is visibly running out off the turn and in the stretch. McNair attempts to keep the inside lane closed off; no violation of AGCO Rule 22.05.01(E).

Race 5 – All Clear

- After the post parade of Race 2, Judges received call from Joey Ayotte (representing Tr. lan Moore) asking to make an equipment change on #1 Cadillac Bayama from an Open to Blind bridle. Ms. Ayotte stated they forgot to call in the equipment change earlier in the day. The Judges denied the request as the Pick 5 wager had already begun in Race 1 and it was not being done due to safety concerns. During the post parade, the Judges observed the horse wearing a Blind bridle. Ms. Ayotte failed to call the Judges after the post parade when requested to do so. When speaking following the race, Ms. Ayotte said she had contacted Mr. Moore at the Meadowlands and he told her to race the horse in the Blind bridle despite the equipment change being denied. Judges will be dealing with Mr. Moore for failing to follow the direction of the Judges and making an unauthorized equipment change. The horse was the second choice in the betting and finished 3rd.

Race 6 – Reviewed second quarter set by #6 Major League (Ed Hensley) – :26.2, :56. Judges spoke with Hensley regarding the policy being enforced for the second quarter. The horse faded and finished last; no further action needed.

Race 7 – All Clear. Timer malfunction, hand time utilized for race fractions.

Race 8 - All Clear

Race 9 - All Clear

Race 10 - Reviewed pylons on #9 Stonebridge Rex (Doug McNair) around the final turn, finished $3^{\text{rd}} - \text{horse}$ hit multiple pylons but did not go inside any pylons; no violations.

Race 11 – Reviewed pylons on #8 Siddhartha (Trevor Henry) in the stretch, finished 1st – horse hit one pylon; no violations.
