Race 1 – All Clear

Race 2 – Inquiry – Reviewed the start and the break by #8 Sports Box (Bob McClure). #8 caused interference to #7 Erinwood Yves (Sylvain Filion) and an interference break to #6 Hes Stalking You (Jody Jamieson). The interference took place after the start. No placings were needed.

Race 4 – Inquiry – Reviewed the break by #2 Shotgun Jerry (Stephane Poultion) at the start, finished 4th – no violations of the AGCO breaking rule.

Race 6 – All Clear

Race 7 – #11 Twin B Eagle (Scott Young) – finished 10th placed 11th for causing interference while on a break in the stretch. #3 Twin B Fighter (Ed Hensley), #4 Desperate Man (Trevor Henry), #5 Twin B Heart Throb (Chris Christoforou), and #9 Bettor Of The West (Sylvain Filion) were charted with interference. #7 Bettor Sun (Doug McNair) was charted with an interference break.

Race 8 – Reviewed racing in the stretch between #3 Itty Bitty (Doug McNair) and #6 My Baby Girl (Robert Shepherd) – #3 bears in while #6 bears out and the two horses touch wheels. Neither horse is at fault to warrant any placings.
