RACES

Race 1 – Inquiry – Reviewed pylons on #8 Dandys Pandemic (LP Roy) in the stretch, finished 1st. The front tower video shows #8 races inside two consecutive pylons. #8 is lapped at the finish by #3 D A Wicked Shine (Jody Jamieson). Furthermore, #8 gains an unfair advantage by improving his position on #2 At Ease Hanover (Tyler Moore) when he

was inside the two pylons. As a result, #8 finished 1st placed 2nd placed 3rd for racing inside two consecutive pylons and being lapped, and for gaining an unfair advantage by racing inside the pylons.
