Race 1 – #6 Summer Crush (Tyler Jones) made a break at the start, finished 4<sup>th</sup> in the four-horse field.

Race 2 – All Clear

Race 3 – Inquiry – Reviewed racing at the top of the stretch between #1 The Sports Desk (Scott Young), #2 Captain Fear Not (Chris Christoforou) and #5 Manhawk (Bob McClure). The video showed #1 made a break on his own and was not bothered by inside horses. #2 is sitting in the two-hole and drifts out, putting a wheel under #5 and forcing McClure to check his horse, and impeding his progress. As a result, #2 finished 1<sup>st</sup> placed 2<sup>nd</sup> for

causing interference. No penalty to Christoforou, as he attempts to keep his horse behind the leader.

Race 4 – Inquiry – Reviewed pylons on #6 LMC Mr Squishy (Pat Hudon) in the stretch, finished 4<sup>th</sup> – the front tower video shows #6 races inside one pylon. The Panel ruled #6 did not gain an unfair advantage going inside the pylon and was forced in by #7 Slayin Theday Away (Eddie Green). No violations of the AGCO pylon rule by #6.
