Race 1 – #6 Spicy Red Head (James Macdonald) was charted with interference due to the break by #5 ER Norma (LP Roy) after the 3/4s, no placings needed.

Race 6 – Reviewed racing in the stretch – #3 Whichwaytothebeach is running out slightly, driver Sylvain Filion attempts to keep the horse down and the inside lane closed off. No violation of AGCO Rule 22.05.01(e) by Filion.

Page 2 - Reviewed the break by #4 Jilliby Dynamite A (LP Roy) after the start – horse breaks on his own.

Race 7 – All Clear

Race 8 – Reviewed the break by #6 Goldies Rockin (James Macdonald) in the third quarter – horse makes a break while on the lead, no interference to any trailing horses.

Race 9 – Inquiry – Reviewed pylons on #1 Southwind Oncore (Travis Cullen) past the quarter, finished 4<sup>th</sup> – the back tower video shows #1 races inside three consecutive pylons. Cullen stated he was forced inside the pylons to avoid contact by #4 Locatelli (Chris Christoforou). The video confirmed Cullen's statement, as #1 received pressure from #4 and went inside the pylons for safety. #1 was charted with interference and not in violation of the AGCO pylon rule.

- Reviewed pylons on #3 Franks Angel (Bob McClure) past the quarter, finished 3<sup>rd</sup> – races inside one pylon, no violation of the AGCO pylon rule.

Race 10 – All Clear. Trevor Henry (#5 Bettor B Sirius) to be in for a film review for urging and failing to keep both feet in the stirrups.

Race 11 – Inquiry/Accident – #1 Vis A Vis Bluechip (Paul Davies) drifts out in the stretch and touches the front leg of #6 Brigus (Sylvain Filion), which causes that horse to fall. #4 Holy Jalapeno (Phil Hudon) is behind #6 and falls. #1 finished 4<sup>th</sup> placed 7<sup>th</sup> and was disqualified for causing interference. #3 Purely Wicked (Jonathan Drury) was charted with an interference break and #7 Ballykeep Painter (Bob McClure) was charted with interference. Filion was checked by EMS and cleared to drive. Hudon was transported by ambulance to a local hospital. Judges will follow up with Davies. Dr. Ballinger treated both horses for abrasions.
