OFFICE

- Race Officials spoke with Trainer Carmen Auciello regarding the change of performance in Momas Son Byrne from Race 9 on September 8/22. This was Mr. Auciello's first start off the claim with the horse and he made several equipment changes that he thought would help improve the horse's performance. The horse has showed making several breaks, so he shortened the hobbles. During the race, the horse was putting in steps down the backside, but Drury was able to keep the horse pacing. Also, the horse tended to be looking around while on the track, so he made changes with the horse's head gear and bridle in hopes it would keep him focussed during the race. The Panel accepted Mr. Auciello's explanation and no further regulatory action is needed at this time.

Race 5 – Inquiry – Reviewed #5 Girl In A Tavern (Jonathan Drury) coming to the half, finished 4th. The horse does not make a break or cause interference to #9 Morethanmyhometown (Austin Sorrie). Drury stated his horse was grabbing on in the hole due to the slowing pace. No placings needed.
